SUMMARY

Offer Price and Net Proceeds

- The Offer Price has been determined at HK\$1.24 per Offer Share (excluding brokerage fee of 1.0%, SFC transaction levy of 0.0027% and the Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$1.24 per Offer Share, the net proceeds from the Global Offering to be received by the Company (before any exercise of the Over-allotment Option and without taking into account any Shares to be allotted and issued upon the exercise of the options granted under the Share Option Scheme), after deducting the underwriting fees and commissions and estimated expenses in relation to the Global Offering paid and payable by the Company, are estimated to be approximately HK\$194.0 million.

Applications under the Hong Kong Public Offering

- A total of 9,477 valid applications were received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS, through the **HK eIPO White Form** service (www.hkeipo.hk) under the **HK eIPO White Form** for a total of 441,954,000 Hong Kong Offer Shares, representing approximately 24.55 times of the total number of 18,000,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.
- As the very significant over-subscription in the Hong Kong Public Offering was more than 15 times but less than 50 times of the number of Offer Shares initially available under the Hong Kong Public Offering, the reallocation procedures as described in the section headed “Structure and Conditions of the Global Offering — Hong Kong Public Offering — Reallocation” in the Prospectus have been applied. A total number of 36,000,000 International Offer Shares have been reallocated from the International Offering to the Hong Kong Public Offering. As a result of such reallocation, the final number of Offer Shares allocated to the Hong Kong Public Offering is 54,000,000 Shares, representing 30% of the total number of Offer Shares available under the Global Offering (before any exercise of the Over-allotment Option and without taking into account any Shares to be allotted and issued upon the exercise of the options granted under the Share Option Scheme).

International Offering

- The final number of Offer Shares allocated to the placees under the International Offering is 126,000,000 Shares, representing 70% of the total number of the Offer Shares initially available under the Global Offering (before any exercise of the Over-allotment Option and without taking into account any Shares to be allotted and issued upon the exercise of the options that may be granted under the Share Option Scheme). The Offer Shares initially offered under the International Offering have been moderately over-subscribed.

Over-allotment Option

No over-allocation of the Shares was made in the International Offering. Therefore, it is expected that the Over-allotment Option will not be exercised, and there will not be any stock borrowing arrangement for the purpose of covering the over-allocation.

Based on the Offer Price of HK\$1.24 per Offer Share, the net proceeds from the Global Offering to be received by the Company, (before any exercise of the Over-allotment Option and without taking into account any Shares to be allotted and issued upon the exercise of the options granted under the Share Option Scheme) after deducting the underwriting fees and commissions and estimated expenses in relation to the Global Offering paid and payable by the Company, are estimated to be approximately HK\$194.0 million. The Company intends to apply such net proceeds for the following purposes:
